



WASTE MANAGEMENT CHARGES FOR 2009/2010

Charges are Operative from 1 July, 2009

The 2009 / 2010 Waste Management Charge levied on properties where a service is provided:

RESIDENTIAL PROPERTIES – PRO-RATA / QUARTER

A council service is mandatory for residential properties.

Residential Properties – Pro-rata fees for new & additional bins.

Note: Residential Services ARE NOT subject to GST.

Residents may pay for an additional Recycling Service/s **or** may apply for a free Additional Recycling (one (1) only) 240lt Bin.

Application Process with set Criteria made through the Environment Department (Waste & Litter Campaign Officer).

Residential Properties requiring more than three (3) of each / any service require approval by the Waste Services Contract Manager.

COMMERCIAL PROPERTIES – PRO-RATA/QUARTER

A service is optional for commercial, industrial, non-rateable properties and a house behind a shop.

Commercial Properties – Pro-rata fees (inc GST) for new & additional bins.

All non-rateable properties (except non-rateable residential) are to be regarded as “commercial”.

Note: Commercial Services ARE subject to GST

Commercial properties requiring more than three (3) of each / any service require approval by the Waste Services Contract Manager.

Stolen/Loss of Bin:	Statutory Declaration required
Cancellation / Withdrawal of Service:	Required in Writing / No refund of monies paid (if the service is cancelled within the initial 12 months <i>or if the service is withdrawn</i> by Council)
