3.1 Election of the Deputy Mayor for 2023-2024

The Mayor invited nominations for the Office of Deputy Mayor for the 2023/2024 Council Year.

Cr Sue Baker nominated Cr Brad Hill for the Office of Deputy Mayor and Cr Harvey seconded the nomination.

Cr David Asker nominated Cr Kris Bolam for the Office of Deputy Mayor. Cr Bolam declined the nomination.

Cr Kris Bolam nominated Cr Liam Hughes for the Office of Deputy Mayor, Cr Tayler seconded the nomination.

In accordance with Council's Governance Rules, both candidates spoke to their nomination.

There being two nominations the Mayor invited Councillors to vote for their preferred candidate by show of hands and noted 3 votes in favour of Cr. Hill and 5 votes in favour of Cr. Liam Hughes, as detailed below:

In favour of Cr Brad Hill: Cr. Baker, Harvey, Hill (3)

In favour of Cr Liam Hughes: Cr. Bolam, Asker, Conroy, Tayler, Liam Hughes (5)

Having received an absolute majority of votes, the Mayor declared Cr. Liam Hughes elected to the position of Deputy Mayor of Frankston City Council for the 2023/2024 period.
