- E.P.A Noise Control Guidelines will apply to these permits and the amenity of the surrounding area must not be adversely effected by noise, dust or smell associated with the permitted activity
- Permits will only be issued for private recreational use and not for financial gain
- The days and times upon which the permitted vehicles may be used will be specified on the Permit

 The maximum period for which a Permit can be granted is 12 months, extensions will only be considered upon re-application for the
- The number and type of vehicles subject to each permit will be determined according to each application
- The number of permitted vehicles that may be operated at any given time will be determined for each permit
